1. Request to approve a new multistate proposal, NE\_TEMP1601: Eastern White Pine Health and Responses to Environmental Changes [10/2016-09/2021] Need to assign an Advisor. Fred Servello is the sponsoring Station Director.

Action: MAC recommends approval and encourages additional participation of scientists from the region. Fred Servello agreed to serve as Advisor.

 Request to approve a new multistate proposal, NE\_TEMP2361: Explorations into the Turfgrass Phytobiome: Establishing Standardized Research Methodology for Studying Microbial Communities and Developing Reliable Applications for Turfgrass Management [10/2016-09/2021] Need to assign an Advisor. Adel Shirmohammadi is the sponsoring Station Director.

Action: MAC recommends approval and advises the group to narrow the focus and establish a baseline for one or two types of turfgrass. Pat Vittum agreed to serve as Advisor and will help get them off the ground and set the project's direction.

 Request to approve a proposal for a multistate Coordinating Committee, NEERA\_TEMP1601 (currently NEERA1001): Northeast Pasture Consortium Collaboration [10/2016-09/2021]

Action: The Committee has a long history and continues to serve as a formal structure to bring experts and stakeholders together. MAC recommends approval.

Action: This is another committee that has a long history that brings research and extension experts together and helps prioritize IPM projects in the region. MAC recommends approval.

 Approve the Request to Write a Proposal for NE1231 - Collaborative Potato Breeding and Variety Development Activities to Enhance Farm Sustainability in the Eastern US [10/2017-09/2022]

Action: MAC recommends approval of Request to Write, and advises the group to focus on the accomplishments in the last five years and relate outcomes with the project's objectives.
