WHEREAS, Dr. Gloria S. Wyche-Moore has distinguished herself as the Dean of Community Outreach and Extension Services (COES), Director of the Agricultural Experiment Station (AES) and the Cooperative Extension Service (CES), and Director of the Water Resources Research Institute (WRRI) at the University of the District of Columbia, and

WHEREAS, Dr. Wyche-Moore has been with UDC for more than three decades, serving as a professor and Chairperson in the Department of Biological and Environmental Sciences, and as an Assistant Dean in the former College of Life Sciences, and

WHEREAS, Dr. Wyche-Moore has left a significant legacy in her long career in the founding of the new College of Agriculture, Urban Sustainability and Environmental Sciences (CAUSES) at UDC, and

WHEREAS, Dr. Wyche-Moore conducted research, administered projects, developed curriculum and was the biggest proponent of urban agriculture, and

WHEREAS, Dr. Wyche-Moore's expertise in water pollution biology and oceanography have served her well in her role as Chairwoman of the Board of Directors for the Northeastern Regional Aquaculture Center (NRAC) for five years.

WHEREAS, Dr. Wyche-Moore was Project Director of USDA's Strengthening Grant, and a Cafritz Foundation Fellow and also directed the NASA-funded "Anacostia River Institute for Remote Sensing (AIRS)," which introduced 9th through 12th-grade students and teachers to water quality analysis and monitoring using remote sensing techniques, and

WHEREAS, Dr. Wyche-Moore as the DC-AES Director since 1997, represented the Northeast and served as liaison to the Northeast Academic Programs section and served as Advisor for multistate project NE1039: Changing the Health Trajectory for Older Adults through Effective Diet and Activity Modifications (formerly NE172 and NE1023),

- Can we afford to have as many local experiment stations?

- Do we need to reach out to new stakeholders? Can Kraft, Kellogg, PepsiCo advocate for us? Our Food Science Depts. develop their products.
 - What's at stake in developing these relationships?
 - What other stakeholder that our other colleges have that we can tap into?
 - Food industry
 - Coastal communities
 - Local homeowners' associations
 - Environmental Defense Fund
 - Golf associations
 - Other local community associations

Watershed restoration is one area that Research and Extension should be working together

The NERA Directors felt that the joint NCRA and NERA meeting went well, but time was too short to discuss the real value for developing cross border collaborations. Issues/concerns noted were:

- Spend own \$ in institutions participant will bring their own resources
- Create consortium/corporation very complex
- Personnel issues
- Need to build around geographical needs

A suggestion was made to set up jointly a NCRA/NERA planning grant.

Future Best Practices for joint regional sessions can focus on (1) How we handle funds? and (2) Establishment of a Grant Support Unit in the Experiment Station level, college or university level.

The Northeast Invasive Plant Species Forum was held on March 21-22, 2012 at USDA-ARS, Beltsville, MD and was attended by a diverse group of 32 participants from federal agencies, university and local government practitioners. This made it quite difficult to focus on specific research issues and come up with a set of projects, but the forum was a good venue to educate the practitioners about the multistate process and was a good start for a fruitful collaboration. The Planning Committee met after the forum and will continue to follow-up on the recommendations. Dr. Cameron Faustman is spearheading a group at UCONN, and the plan is to develop a multistate project to allow interested faculty from other institutions to react to something concrete. The forum attendees will be invited to participate. The practitioners will hopefully provide the Extension piece.

Bill Hare noted that a request for a "directed" planning grant on *Ethnic Foods* to be funded jointly by NEED and NERA will be proposed (\$4K each). Linda Kay and Dan Rossi will continue the discussion and when the proposal is ready it will be presented to the NERA Directors for their approval. Bill added that UDC, UMASS, Cornell, UMD, WVU and UDEL are collaborating in this activity, as it also relates to the Feed the Future initiative. As noted in the MAC Report, Ethnic Foods is one of the three initiatives that resulted from the Northeast Food Systems Forum that NERA jointly organized and funded with NEED.

Action: The 2013 announcement will be prepared by Dr. Rossi and will be released in November.

The North Central Executive Summary of the Batelle Study was shared with the Directors and the proposal for the Southern Region. The topic was also discussed by the Deans at their AHS Meeting. The purpose of the discussion is to assess the level of interest among the station directors, and if the study should be done as a region or as a component of our region, or in the institutional level.

Dr. Hoffmann captured the discussions, and sent the following summary:

From the discussion at the AHS and NERA meetings, Gary Thompson and I captured the following pros and cons of conducting such a study.

- Several attending NE deans had the impression the deans in midwest never used the data generated by Battelle this raised red flags
- There is value in having a third party prepare such a report, since it gives it more credibility and it's not coming from "us"
- The aggregate data is not detailed enough to be of value locally comment from the new dean at DC, an economist. At the same time if one is advocating for the region then it has value.
- Raising the region's profile was seen as something important to come out of a Battelle study. In contrast to the other regions we are often not considered a major player in ag and the food industry.
- Some states already have their own reports. Not sure what a Battelle study would add for their state.
- The Battelle study should be shared with our own economists to get their assessments as well as see if they could do a better job for our states.
- Sense from NERA was that there is interest but members need more information. Most NERA members were not concerned about the potential cost of \$5-10K. The option of dividing the cost proportionally based on FFF allocation was considered.
- No decision was made by the AHS group they want to see what NEED and NERA decide.

If you have not yet done so you may want to review the Battelle study conducted for the NC region (attached). This will give you an idea as to what can be included in a study. Note that Battelle is flexible and will customize studies to meet the needs of their customers. Also note that Battelle could do a region-wide study, encompassing all NERA states or break the study out but clusters having a particular affinity such as a watershed or type of agriculture.

Also <u>attached</u> is a statement of work designed for the southern states. This outlines what this group is pursuing but we think modifying it to include the following would likely be more appropriate and helpful for the northeast.

- Rather than the study being led by AES and Extension directors, the region's deans would be in the lead
- Academic (teaching) programs would be included along with research and extension
- Instead of agbiosciences the study would emphasize agriculture and the food system
- Battelle would be asked to help identify where they are opportunities to partner with programs and physical assets for the mutual benefit of institutions in the region

- The report would be forward looking, helping all institutions build on current strengths to address future challenges and take advantage of future opportunities.
- The impact assessment would be broad and serve to highlight the economic benefits that occur through various mechanisms, including:
 - o Research (applied, translational)
 - Food security, climate change, food safety, energy, nutrition
 - Implementation of technical and practice innovations
 - o Technology transfer
 - Workforce and practitioner development
 - o Teaching and education
 - Youth and family development
 - Community/economic development
 - o Ecosystems services such as maintaining the NY City watershed
 - o Policy development
 - International contributions
 - o Human well being/health (e.g., invasive mosquitoes)

At this point Gary and I are looking for general reactions to a possible Battelle study encompassing parts of, or the entire region. If there is consensus to move ahead, a statement of work would need to be developed that meets the needs of those interested in a study.

Comments, concerns and/or suggestions should be sent to Drs. Thompson and Hoffmann.
