4	 NIFA Update – Hiram Larew, NIFA FY2011 Budget is still uncertain. CR is extended until April 8. Travel has been reduced by 20%. NIFA is looking into creative ways of obtaining funding from federal partners and the private sector, and real emphasis continues for integration of R-E-T. The NIFA International Program is focused on solving problems at home but also beneficial abroad, enhancing competitiveness of American agriculture, and global food security. Feed the Future - awareness of LGUs seems minimal. Meeting is by invitation only. Dr. Larew will check if the next meeting is open to broader participation. REE Action Plan – asks for response/comment from the system but LGUs were not involved in its development. Dr. Larew will share this feedback with USDA.
5	USDA-ARS Update - Dariusz Swietlik, ARS ARS is generally in the same situation as other USDA agencies and operating under a CR. Nine labs are slated for closure. The proposed budget has \$44M cut in earmarks, but actual cut may even be higher. ARS is undergoing a cultural transformation aimed at recruitment and retention of talent. ARS is also engaged in responding to the stinkbug problem in MD, PA and WV.

Supporting Campus Dairy Operations in the Region

A regionalization of dairy operations and course offerings was discussed. UNH operates an organic dairy but does not have enough faculty/courses to fulfill a 4-year dairy major. Most stations have closed their dairy operations. Penn State, ARS and UVM faculty are doing research at UNH. Cornell needs faculty for some animal science courses. Cornell is also planning to dispose their dairy processing equipment. Dr. Hoffmann will inform Dr. Brady if a decision has been made. A suggestion was made to pick a course and for two schools in the region to work out an arrangement, and inform everyone in the region. If it works out, then it could be replicated by others.

Action: A motion was made to approve the FY2012 regional off-the-top funding for NE-9 in the amount of \$224,973 and NE-59 in the amount of \$40,788. The motion was seconded and approved.

NRSP Discussion

Action: The motion made to approve the proposal was seconded and passed.

NRSP3, NRSP4, NRSP7, NRSP8 and NRSP9

Action: MAC recommended approval of off-the-top requests [refer to MAC Report for details of each recommendation]. All agreed without further discussion except for NRSP6.

NRSP6 – The US Potato Genebank

When the proposal was originally approved, the NRSP Review Committee questioned why commercial users were not expected to pay for services. The proposal was approved after the Univ. of Wisconsin made a commitment to work with the technical committee on devising a mechanism on how to charge the private sector. There was concern that that strategy has not been laid out. The Directors want this added as a caveat before approving their off-the-top request.

The NERA Directors also raised the issue of putting a cap on each of the NRSPs. Is there a strategic approach to putting a cap on the NRSPs? This cap issue and concerns about NRSP6 will be raised at the next NRSPRC meeting.

	NERA Planning Grant
	The Directors are pleased with the outcome of the NERA Planning Grant and expressed their support to continue the program. They also thanked the MAC members for their diligent review of submissions and selection of successful proposals. An update will be given at the next meeting as we are still receiving reports from the grant recipients.

15	Invasive Species Update – Fred Servello and Cameron Faustman A planning committee led by Drs. Servello and Faustman will be formed. The committee will decide what specific areas of invasive species will be covered. Faculty will be involved in the planning process. A regional forum/workshop, a "Northeast Invasive Species Forum", was suggested to provide a venue for the faculty to collaborate on areas of common interest that may lead to a multistate project, a proposal for competitive funding or to form teams to go after funding opportunities. Possible topics may include strategies for management of invasives using a systems approach, and may include terrestrial & aquatic plants, economics, remote sensing, social science research, human health, etc. The planning committee will be charged to develop the theme. The Directors will be asked to submit names of faculty, 1-2 per station with their specialties. Ecologists and economists will be needed. NERA will help facilitate the meetings and work of the committee.
	Dr. Tim Phipps and Dr. Adel Shirmohammadi will share information on past workshops related to invasive species that the committee may find useful in planning for the regional forum.
