MAC is concerned that the proposal stated that it will develop specific methodology in the first year. At this stage, the proposal should already have a well developed executable research methodology to be considered a multistate project. Perhaps it is better suited to be a NEERA project. However, it will still lack the specifics needed to qualify for multistate funding, other than travel, if it were to be a NEERA. It is a very ambitious project, but does not seem to have enough participants/expertise to complete the tasks. It reads more like an umbrella project.
