## Action items:

• The APLU hosted a webinar, *Agricultural Research Infrastructure Advocacy*, on Monday. The webinar shared the intent of the APLU to advance a \$11.5 billion request for research infrastructure support. The NERA Executive Committee is drafting a document expressing reflections on the effort. We're also seeking your input and perspectives on this initiative.
